3. DISCUSSION ITEMS:

3.1. Employee Appreciation

Councilman Graham would like to start celebrating employee appreciation and has been looking into catering lunch two (2) times per month to show appreciation to all city employees. Councilman Anderson stated that we cannot use tax payers' money to benefit or to feed on a regular basis the city employees. However, you could pay for it out of the enterprise fund, the water fund but he wouldn't recommend creating that expense every month. Mayor Grooms suggested that he would help pay for it or he will ask his church group and local churches to help administer the lunches twice a year. Council suggested that Councilman Graham pick two dates and bring it back to them for further discussion.

3.2. Safety Coordinator - Jim Stanoff

Turned in an inspection item list to public works with (forty-five)45 items that require attention and asked for an update. Mayor Pro-Tem stated that they have not been able to get to yet. Mr. Stanoff stated that every city owned building requires a safety designated smoking section, he would like for council to let him know where they would like these areas to be. Mr. Stanoff should report to Lori Phillips the City Clerk for any items that need to be made for safety purchases.

3.3. FY 2022 Budget Amendment Discussion

Per Councilman Anderson - discussed projected revenues, it appears that we will have \$1,487,453.31 worth of revenues that came into the city from all sources, this is what we have to spend. Councilman Anderson is projecting that if what we do is continue to spend on what we spend on average per month for the duration, we will spend \$1,335,224.00 and we still have to do a budget amendment because our departmental expenditures for the most part are over and as a result, we have to allocate more money for those line items. We have \$77,013. 00 that will have to be redistributed to cover the over expenses in police and streets, therefore we need to be very cautious moving forward on what we are spending money on.
