 - d.) Ordinance to provide temporary incentives to subdividers of land to be Annexed into the City and to repeal existing water tap incentive (Possible first reading)

Meeting called to order at 5:55 pm. In attendance are Councilman Anderson, Mayor Pro-Tem Gwinnett, Mayor Grooms, Councilman Griffith, Councilman Stanoff, City Administrator/Clerk Wirth and Councilman Schlierf was in attendance on speaker phone.

Mayor Grooms gives the invocation.

Councilman Stanoff gives a presentation on fencing the property around the Police Department building and public works building. After a brief discussion the Mayor and Council agreed that it would be done.

City Administrator/Clerk Wirth informed the Mayor and Council the tap fee for residential water was never changed from \$450.00 to \$600.00 and it was supposed to

be done before she had employment at the City of Brooklet in 2016. After a brief discussion the Mayor and Council agreed to add ¾" tap fee for \$600.00 and 1" tap fee for \$800.00 to the ordinance to specify the size. Mayor Grooms asked for a motion to approve the first reading of the ordinance for a tap-in fee for each residential unit and adding the above text to it. Councilman Griffith made a motion to approve the first reading with added text. Councilman Anderson seconded the motion, all in favor, motion carried by majority vote of Councilman Anderson, Mayor Pro-Tem Gwinnett, Councilman Griffith and Councilman Stanoff. Councilman Schlierf did not vote.

City Administrator/Clerk Wirth informed the Mayor and Council again this ordinance for water tap in fees for fire protection was not voted in either. After a brief discussion Mayor Grooms asked for a motion to approve the first reading of this ordinance. Mayor Pro-Tem Gwinnett made a motion to approve the first reading of this ordinance. Councilman Stanoff seconded the motion, all in favor, motion carried by majority vote of Councilman Anderson, Mayor Pro-Tem Gwinnett, Councilman Griffith and Councilman Stanoff. Councilman Schlierf did not vote.

Mayor Grooms asked for a motion and discussion to change the City of Brooklet's building permit fees to match that of Bulloch County's building permit fees. After a small discussion Mayor Grooms asked for a motion to approve. Mayor Pro-Tem Gwinnet made a motion to approve the building permit fees. Councilman Stanoff seconded the motion, all in favor, all in favor, motion carried by majority vote of Councilman Anderson, Mayor Pro-Tem Gwinnett, Councilman Griffith and Councilman Stanoff. Councilman Schlierf did not vote.

Mayor Grooms asked for a motion to have the first reading of the ordinance to provide temporary incentives to subdividers and repeal existing water tap incentives. After a brief discussion Councilman Griffith made a motion to approve the first reading of this ordinance. Councilman Anderson seconded the motion, all in favor, all in favor, motion carried by majority vote of Councilman Anderson, Mayor Pro-Tem Gwinnett, Councilman Griffith and Councilman Stanoff. Councilman Schlierf did not vote.

Mayor Grooms asked for a motion to adjourn the meeting. Councilman Stanoff made a motion to adjourn the meeting. Mayor Pro-Tem Gwinnett seconded the motion, all in favor, all in favor, motion carried by majority vote of Councilman Anderson, Mayor Pro-Tem Gwinnett, Councilman Griffith and Councilman Stanoff. Councilman Schlierf did not vote.
