Proposed 10' inch line connecting Brooklet to Statesboro with a pumping station somewhere in the city of Brooklet, maybe a secondary location like the scout hut. At the end of this project, this is a 50/50 project, 50% Brooklet, 50% American Recovery, you will have one very large lift station with large pumps capable of pumping sewage five (5) miles and lifting it approximately 30 to 40 feet in elevation to Brooklet and Statesboro plus the depth of the wet well which will be another 20 feet and it will be able to lift sewage 60 feet and pump it roughly five miles, you won't have anyone connected. This project is just the infrastructure to get it there but from that point on, then you will to start constructing outwards and none of that is funded, so its just the bones, the structure is what is funded and from that part you have to figure out what is the cities priority, which area do you want to serve first or do you want to focus on new areas. By the year 2026 the project needs to be completed. Wesley Parker recommends putting together a negotiating team together in order to negotiate with the City of Brooklet.
